Area Need Improvement	For two CBDS locations, staff who were attending swimming sessions with individuals did not have Water Safety Training. The agency needs to ensure that during swimming activities, staff present must have Water Safety Training.
Process Utilized to correct and review indicator	Staff at both Launch locations are always present when the individuals are swimming. All current Launch staff are water safety trained. Going forward, water safety training will be incorporated into the new staff orientation/ onboarding process.
