DECISION

MAHARAJI INC. D/B/A SMITTY'S PACKAGE STORE 16 COLLEGE HIGHWAY SOUTHAMPTON, MA 01073 LICENSE#: 121200010

VIOLATION DATE: 08/08/2016 HEARING DATE: 12/14/2016

Maharaji Inc. d/b/a Smitty's Package Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Wednesday, December 14, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Carey's Report.

The following documents are in evidence:

- 1. Investigator Carey's Compliance Check Field Report dated August 8, 2016; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, August 8, 2016, at approximately 8:00 p.m., Investigators Temple and Carey ("Investigators") investigated the business operation of Maharaji Inc. d/b/a Smitty's Package Store.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12 oz. can of Budweiser Light beer for one dollar and fifty cents (\$1.50). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for approximately 10 years with no prior violations, the Commission issues a **WARNING**.
