DECISION

BALAJI INC. D/B/A THOMAS VARIETY CONVENIENCE 58 E MAIN ST. SOUTHBRIDGE, MA 01550

Balaji Inc. d/b/a Thomas Variety Convenience (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 15, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report dated May 25, 2016; and
- 2. Licensee's Stipulation of Facts.
- A. TIPS Certificates for Employees.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, May 25, 2016, at approximately 7:22 p.m., Investigators Di Cicco and Keefe ("Investigators") investigated the business operation of Balaji Inc. d/b/a Thomas Variety Convenience.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12 ounce can of Coors Light beer for one dollar and thirty-five cents (\$1.35). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 15 years with no prior violations, the Commission issues a **WARNING**.
