COMMISSION ORDER

The Alcoholic Beverages Control Commission ("Commission") held a hearing in this appeal on July 18, 2019. During the hearing, both the licensee, The Twelve Crane Street Corp. d/b/a Dark Horse Pub, and the Town of Southbridge Liquor Licensing Board agreed that the appeal should be remanded to the Southbridge Liquor Licensing Board so that the licensee may file an alteration of premises application to eliminate the second floor from its description of licensed premises, the approval of which would eliminate the necessity for this appeal before the Commission.

With the parties' agreement, this matter is **REMANDED** to the Southbridge Liquor Licensing Board so that it may consider any alteration of premises application from the licensee. This remand applies only to this matter and not to the other two matters heard on July 18, 2019, involving this licensee.
