		Here are my suggestions for improving the Corridor (PART 1):  1) IMPROVE CLARITY OF BIKING/WALKING PATHS - Clearer demarcation of biking vs walking pathways, e.g., like the section near Northeastern University next to the fields. Frequently, pedestrians are walking in the bike pathway which can be dangerous. It is very confusing that the biking/pedestrian paths change from left to right.  2) IMPROVE WALKING SECTION - Adding a walking section in the shade of the trees. Much of the walking pathways tend to be closer to the street and without shade, I'd strongly suggest having two pathways that are off the street and through the trees - one for biking, one for walking.  3) IMPROVE TREES/SHADE - Replace trees and add canopy/density of plantings. I'm very thankful for all the mature trees along the Corridor. I've seen some trees die and get removed. And some areas don't have dense tree cover for shade. Please add more trees along the pathways and replace all tree/shrubs that have been removed. A) ADD TO DENSITY OF PLANTINGS FOR HABITAT/FOOD/GARDENS - Add density to the plantings to serve as habitat for songbirds, insects/pollinators, etc. And, add woody food producing plants (since they don't uptake led into the fruiting bodies of the plant), e.g., blueberry bushes, raspberry patches, paw paw groves, current bushes, hybrid Asian pears that don't require much care, persimmons, etc etc. Also, add sections for community gardening. The garden spaces all seem totally full, so increase capacity for more gardeners. (I'm running out of characters so I'll submit a second form.)			
Alex	Alvanos	Comments for improvement (PART 2): 5) SAFETY/BIKEABILITY - Add better safety at connection points between pathways/streets, e.g., flashing pedestrian signs. Green cross walks. Many of the right turns have both a green light for cars, and a walk/bike signal for pedestrians which is dangerous. I've almost got hit many times by cars turning, or going too fast trying to run a yellow light. 6) IMPROVE BIKING in BAY VILLAGE SECTION - Biking in Bay Village section is not clear and onerous. I don't know where I'm supposed to ride on the sidewalk vs in the street. I always feel like I'm in the pedestrians way, or going the wrong way down a one way street next to the walking path. 7) IMPROVE BIKING SAT JACKSON SQUARE/CENTRE STREET, & ROX CROSS/TREMONT ST — Two things. a) these are the longest intersections to get through (the walk signal takes a long time to come on). These intersections prioritize cars/street traffic, and takes a long time to get through as a biker/walker. Improve this especially for commuting times so bike/walking commuters can move faster too. b) these sections tend to have the most bike/walk traffic to get through a small curb cut. These could be widened, expanded. 8) IMPROVE BIKE SECTIONS NEXT TO STONY BROOK STATION, RUGGLES/NORTHEASTERN PARKING GARRAGE, ROX CROSSING STATION, and MASS AVE STATION - these tend to be the worst marked for bikes Vs pedestrians and can be dangerous areas where collisions happen. Clearly demarkae paths for pedestrians and bikers. Paint lines. Create separate paths. Make it clearer and better for both to be able to use those sections without running into each other. 9) LIGHT UP BASKETBALL COURTS — this seems racist from the outside. Many of the tennis courts have lighting at night, but not the basketball courts. Add lighting. Put the lighting on one of the buttons you press, so people can walk up and use the court (but lights aren't always on so don't waste electricity). Have the lights go til 11pm or later. 		There are a number of intersections, particularly on the more eastern side in Roxbury, that are very dangerous and open up users of the path to right hook accidents by vehicles traveling on Columbus Ave. The particular ones I have in mind are:			
		- The Prentiss Street intersection near Wentworth Institute of Technology. Often times there are many cars blocking the crosswalk here, making it hazardous to see if there are cars in the far lane while crossing.	1		
		- The Cedar Street and Heath Street intersections are in need of signal separation. There is a high risk of right hooks from vehicles traveling on Columbus Ave as the walk signals are at the same time as the green light for those intersections. I have almost been hit on several occasions when crossing Heath Street, as this tends to be a very busy intersection			
		While understanding that a number of these intersections are likely the responsibility of the City of Boston rather than DCR, I would hope that the organizations can work together to make these safer for path users.
