DECISION

208 SOUTHWICK INC. D/B/A MILLIE'S COUNTRY STORE 208 COLLEGE HIGHWAY SOUTHWICK, MA 01077 LICENSE#: 88881-PK-1222

208 Southwick Inc. d/b/a Millie's Country Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, April 30, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino & Fleming's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Guarino & Fleming's Minimum Purchase Age Compliance Check Field Report, 3/6/2024;
- 2. ABCC Form 43, Transfer of License;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, March 6, 2024, at approximately 6:06 p.m., Investigators Guarino and Fleming ("Investigators") conducted a compliance check at 208 Southwick Inc. d/b/a Millie's Country Store.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16-ounce can of Bud Light beer, for two dollars (\$2.00). The underage operative was not asked for identification.
- 3. The Licensee holds a license under M.G.L. c. 138, § 15 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
