This letter is to inform you that the Department of Public Health ("Department") has reviewed Mass Organic Therapy, Inc.'s *Siting Profile* (Application 2 of 3). The *Siting Profile* requires the following information before the Department may complete its evaluation:

1. Please submit a list of businesses within 500 feet of the proposed Hanover site for review for compliance with 105 CMR 725.110(A)(14). Please also specifically address the proximity of the Kumon Math and Reading Center of Hanover, located at 2053 Washington Street.
2. The Department has initiated the verification process for the letter of support/non-opposition from the Webster Board of Selectmen. Please note that a representative of the Town has informed us that the Board was not aware that the Webster site would be cultivating and processing for two retail sites – one in Oxford and one in Hanover. We are awaiting further information from the Town before we conclude the verification process.

If the applicant has been requested to resubmit their response to a question, please do so using the page on the application form for that particular question, and include an initialed attestation at the bottom of the page. The applicant need not resubmit the entire application and may submit only the page for the particular question that needs to be submitted.

Please remember to type all responses in the information or materials resubmitted to the Department, other than any required signatures, as well as include the name of the Applicant Non-Profit Corporation *and* the number of the application (e.g., Application 1 of 1) at the top of each page of the resubmitted information or materials.


