# Meeting called to order at 9:31 am. Housekeeping

- Meeting Called to Order
  - Board chair called the meeting to order at 9:31 a.m. Mr. Burke initiated introductions and invited Board staff and members to do the same. Mr. Burke advised members of the public to turn down their volume and camera and utilize the hand function to address the Board.

### **Board Business**

- Approve Public Session Minutes
  - o Minutes of 10/3/22 meeting

The Board reviewed the draft of the public session minutes of the August 1, 2022 Board meeting. **Dr. Laffan moved to approve the minutes as presented. Ms.**Noonan seconded. The motion passed on a roll call vote: **Dr. Laffan – "Yes"**; Ms. Young-Hong – "Yes"; **Dr. Bresnahan – "Yes"**; **Dr. Simone – "Not Present"**; Ms. Noonan – "Yes."

- Report from Executive Director, Thomas Burke
  - Transfer to the Bureau of Health Professions Licensure within the Department of Public Health

Mr. Burke welcomed Board members and the public to the initial meeting at the Bureau of Health Professions Licensure within the Department of Public Health. Board members and staff offered introductions. Mr. Burke reminded the Board of the new electronic licensing system in effect for licensed providers.

## • Report from Board Counsel

 House Bill 5094: An Act providing for provisional licensure for speech-language pathologists

Sheila York and Lauren Nelson reviewed the status of new legislation for the provisional licensure of speech-language pathologists and discussed the timeline for implementation. The Board expressed its support for the legislation and implementation in Massachusetts. Ms. York thanked the Board for its input and

discussed the procedures needed. Board counsel and executive director will guide the Board on this topic at subsequent meetings.

### **Discussion**

- Regulation Review Advisory on FDA rule on Over the Counter Hearing Aids
  - Mr. Burke reminded the Board that the FDA rule permits the selling of hearing instruments over the counter to treat mild to moderate hearing loss for those over the age of 18. The Board noted that there are "gray areas" in matters of public safety that the Board should consider when implementing the law. Specifically, the Board raised a concern for maximizing consumer protections in the new regulations. The Board instructed staff to include this topic for further discussion.

Closed Session: Investigatory Conferences, pursuant to G.L. c. 112, §65C.

At 10:07 a.m., Dr. Laffan moved to exit open session and enter into closed session to conduct investigatory conferences, pursuant to G.L. c. 112, §65C, and not return to the public meeting. Ms. Young-Hong seconded the motion. The motion passed on a roll call vote: Dr. Laffan – "Yes"; Ms. Young-Hong – "Yes"; Dr. Bresnahan – "Yes."; Dr. Simone – "Not Present."
