DECISION

CREATIVE ENTERTAINMENT CONCEPTS, INC. DBA SKYPLEX P.O. BOX 1610 SPRINGFIELD, MA 01101 LICENSE#: 122600149 HEARD: 04/19/2011

Creative Entertainment Concepts, Inc. dba Skyplex (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, April 19, 2011, regarding an alleged violation of M.G.L. c.94, §186 (18 counts). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Brad Doyle's report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Brad Doyle's Report; and
- 3. Four (4) Bottles of Liquor.

There is one (1) tape of this hearing.

FACTS

- 1. On Friday, December 10, 2010, at approximately 11:00 p.m., Investigator Kujawski and Doyle investigated the business operation of Creative Entertainment Concepts, Inc. dba Skyplex.
- 2. Upon entering the premises, investigators identified themselves to the manager on duty and informed her they would be conducting an inspection of the bar area.
- 3. While inspecting the contents of the bar, Investigator Kujawski found bottles of alcohol which contained foreign matter, specifically fruit flies.
- 4. Eighteen (18) one (1) -liter bottles were taken as evidence.
- 5. The owner of the establishment was then spoken to and informed of the violation.
- 6. The licensee testified that his establishment holds hundreds of people and he stocks over one million bottles. He also stated that he has hired an exterminating business to alleviate the problem.

CONCLUSION

Based on the evidence, the commission finds the licensee violated M.G.L. c.94, §186 (18 counts). The Commission suspends the license for eighteen (18) days of which eighteen (18) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission regulations occur.
