DECISION

OM ARMORY LIQUORS LLC D/B/A RACING MART 140 ARMORY STREET SPRINGFIELD, MA 01109 LICENSE#: 89855-PK-1226

VIOLATION DATE: 6/13/2022

HEARD: 10/11/2022

Om Armory Liquors LLC d/b/a Racing Mart ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 11, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Minimum Purchase Age Compliance Check Field Report, 6/13/2022;
- 2. ABCC Licensing Authority Certification, Transfer of License approved, 9/21/2020;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Monday, June 13, 2022, at approximately 7:16 p.m., Investigator Keefe ("Investigator"), inspected the business operation of Om Armory Liquors LLC d/b/a Racing Mart.
- 2. An underage operative, working under the supervision of the Investigator, purchased an alcoholic beverage, one 24 ounce can of Bud Light beer, for two dollars and ninety-nine cents (\$2.99). The underage operative was not asked for identification.
- 3. Falguni Patel, Licensee, appeared at the Commission hearing. The Commission was informed all employees had been TIPS certified and since the compliance check were recertified via TIPS. In addition, the Licensee is purchasing a scanner which should be in place shortly.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
