NOTICE OF SUSPENSION

After a hearing on March 15, 2011, the Commission finds Torcia & Sons, Inc. dba Fat Cat Bar and Grill in violation of Massachusetts General Laws c. 138, §69.

The Commission **suspends the licensee's license for a total of five (5) days to be served**. The suspension shall commence on **Wednesday, June 8, 2011 and terminate on Sunday, June 12, 2011**. The license will be delivered to the Local Licensing Board or its designee on Wednesday, June 8, 2011 at 9:00 A.M. It will be returned to the licensee Monday, June 13, 2011.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form. All checks must be certified and accompanied by the enclosed form, which must be signed by a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

Torcia & Sons, Inc. dba Fat Cat Bar and Grill (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 15, 2011, regarding an alleged violation of M.G.L. c.138, §69 (1 count). Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Dennis Keefe's report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and
2. Investigator Dennis Keefe's Report dated December 5, 2010.

There is one (1) tape of this hearing.

FACTS

1. On Saturday, December 4, 2010, Investigators Keefe, Wilichoski and Capurso investigated the business operation of Torcia & Sons, Inc. dba Fat Cat Bar and Grill.
2. Upon entering the bar, their attention was drawn to a male patron in possession of a Budweiser Bottle.
3. The patron was having difficulty keeping his balance and was noticeably swaying from side to side.
4. He also had difficulty placing the bottle in his mouth when taking a sip from the beer.
5. The male patron would shut his eyes for periods of approximately three (3) seconds at a time.
6. The investigators formed the opinion that the male patron was intoxicated.
7. The male patron was joined by another male individual and was witnessed ordering and being served a raspberry kamikaze by the waitress.
8. The investigators notified the Springfield Officer on duty and the manager on the premises.
9. The officer provided safe transport for the male patron.
10. Administrative review of the file indicates violations in 1999 and 2006.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M. G. L. c. 138, §69. Therefore, the Commission **suspends the licensee's license for a period of five (5) days.**
