PURPOSE:

The purpose of this Staff Summary is to request that the Board of Directors authorize and approve the Secretary/CEO, or their designee, to execute MassDOT Contract No. 132185 titled Reconstruction and Related Work on Rhode Island Road (Route 79) from Taunton Town Line to Clear Pond Road, with P.A. Landers, Inc., for the amount of \$17,385,000.00, for a total duration of 1,418 calendar days from Notice to Proceed (NTP).

TOTAL PROGRAM BUDGET:

The project has a total program budget of \$23,110,659.84, which includes the following:

DISCUSSION:

Improvements will include a widened cross section with 11-foot travel lanes and 5-foot shoulders, enhanced pavement conditions through a combination of reconstruction/reclamation and resurfacing, increased safety by addressing sight distance restrictions and providing useable shoulders, providing bicycle and pedestrian accommodations, and improving traffic operations and safety by reconstructing the intersection at Route 18. The project will also include upgrades to the existing drainage system to improve runoff collection and stormwater quality. New sidewalk is proposed along the south/east side of Route 79 until Water Street where it will transition to the north/west side of the roadway until the Route 18 intersection where it will shift back to the south/east side to the end of the project at Clear Pond Road. Modular block retaining walls are proposed at wetland resource area locations to minimize impacts.

PROCUREMENT:

On August 30, 2025, the Highway Division advertised the contract for bids. On September 30, 2025, the Highway Division opened bids for this contract and four (4) bids were received. P.A. Landers, Inc. was the lowest qualified and eligible bidder with a price of \$17,385,000.00. The bids were reviewed by engineers in the Construction and Construction Contracts Sections. The Highway Division has accepted the bid submitted by P.A. Landers, Inc., which at \$17,385,000.00 is 1.1% greater than the Office Estimate of \$17,192,191.00.
