Massachusetts Division of Standards Proposed Municipal Weights and Measures Program Annual Report Card

I. Why:

The Division has found that not all municipal weights and measures programs fully comply with the requirements contained in Massachusetts law. For example, every year the Division fails to receive some statutorily required annual reports from municipalities that are required to file such a report. The Division also receives reports from device owners complaining about their inability to obtain required inspections of their devices. Finally, the Division has received complaints from some consumers about unsealed or inaccurate devices in their communities. One of the Division's primary goals is to ensure that both consumers and businesses in every Massachusetts municipality can rely on legally accurate weighing and measuring devices and retail pricing. To better achieve this goal throughout the Commonwealth, the Division proposes to issue an annual report on the performance of municipal weights and measures programs, which would contain the information detailed below.

II. What:

The Division proposes to create a new document summarizing the performance of municipal weights and measures programs, the Municipal Weights and Measures Program Annual Report Card.

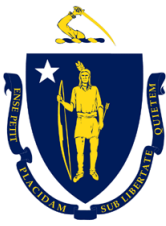
III. Who:

The Division will include in this project:

- A. Municipalities required by Ch. 98, Section 34 to appoint a sealer;
- B. Municipalities that have chosen to appoint a sealer pursuant to either Subsections 35(a)(1) or (3) or Section 36; and
- C. Municipalities with between 5,000 and 20,000 residents who have neither appointed a sealer nor contracted with the Division pursuant to Section 35(a)(2).

IV. How:

The Division will create a document entitled the "Municipal Weights and Measures Program Annual Report Card," that will contain the following information for each covered municipality:

- A. Whether the municipality submitted a completed annual report to the Division, pursuant to Ch. 98, Section 37, by the statutory deadline, January 31;
- B. Whether the municipality owns or has access to equipment to conduct weights and measures inspections that the Division deems adequate and has had that equipment tested and sealed by the Massachusetts Metrology Lab within the previous five years;
- C. Whether the municipality has appointed and registered with the Division one or more sealers in good standing (either the sealer was appointed less than one year ago or is certified by the Division pursuant to 202 CMR 6.02);
- D. Whether the municipality's sealer or sealers have performed and recorded with the Division as directed his or her required continuing education credits, pursuant to 202 CMR 6.07;
- E. The fraction, rounded to the nearest tenth, of the municipality's required weights and measures inspections that are up to date and that have been performed in accordance with NIST Handbooks 44 and 130, as determined by the Division.

The Report Card will issue a final grade for each covered municipality, which shall be the sum of the points earned from the above five standards, with affirmative findings for standards IV.A. through D. each earning one point, which total will then be added to the fraction calculated pursuant to standard IV.E.

V. When:

The Division will conduct inspections described in Section IV.E above throughout the year covered by the Report Card. The Division will issue the Report Card in the spring of the year following the year the Report Card covers.

VI. Other

The Report Card will be provided to the Standing Advisory Committee for its review.

The Report Card will detail any deficiencies found in Section IV.E above, in a way that is understandable to the public.

The Division will use the results to reach out to sealers and/or municipal officials to offer additional training or other assistance.
