
To be licensed as a judge, you must submit the following to this office.

- Completed Application Form
- \$50 Non-refundable Application Fee made payable to the Commonwealth of Massachusetts
- Non-Massachusetts Residents Only: One Passport Photo (2" x 2") of Applicant
- Copy of a Government Issued Photo Identification (e.g. Driver's License/Passport)

Letter of Good Standing if licensed in another state/jurisdiction

D Reference letter from an official in the unarmed combat industry that can attest to your record of competent work
