FY24 Community Transit Grant Program Vehicle Cycle Awards

Through the competitive Community Transit Grant Program (CTGP), MassDOT’s Rail and Transit unit distributes federal 5310 funding and state Mobility Assistance Program funding annually to transit authorities, municipalities, Councils on Aging, and non-profits to enhance mobility for older adults and people with disabilities, including through providing wheelchair-accessible vehicles.

In the FY24 vehicle cycle, MassDOT is awarding 168 vehicles for a total value of \$19,724,810. These awards include 16 fully accessible electric vehicles.
