Statewide Contracts Allowing Payments & Performance Beyond the Statewide Contract End Date

Some OSD statewide contracts include language allowing performance and payment time frames which exceed the Statewide Contract End Date. Term leases, rentals, maintenance, or other agreements for services entered during the duration of the Statewide Contract and whose performance and payment time frames extend beyond the duration of the Statewide Contract shall remain in effect for performance and payment purposes (limited to the time frame and services established per each written agreement). No written agreement shall extend beyond the limit specified in the Statewide Contract. No new leases, rentals, maintenance, or other agreements for services may be executed after the Statewide Contract has expired. To determine if a statewide contract has these extend beyond terms, buyers must review the specific [Contract User Guide](#). The table of contents on the first page of the user guide will include a link to a section titled "Performance and Payment Time Frames Which Exceed Contract Duration." This section of the Contract User Guide will explain the extend beyond terms and timing for the contract. If a contract does not contain this information in the Contract User Guide, then the contract does not have extend beyond language.
