Report to the Office of Consumer Affairs and Business Regulation on the Status of Retail Competitive Electric Markets in Massachusetts -February to April 2005

July 28, 2005

We are pleased to provide the Office of Consumer Affairs and Business Regulation with this Report on the Status of Retail Competitive Markets in Massachusetts. Electric restructuring in Massachusetts is a work in progress. Retail competitive suppliers provide over 33 percent of the total electric energy bought by Massachusetts consumers – predominately large commercial and industrial ("C&I") customers. Conversely, almost all residential and small C&I customers currently receive basic service. It is widely thought that the availability of below-market standard offer service has acted as a barrier to the development of competitive retail markets in Massachusetts. On March 1, 2005, this barrier was removed when approximately 1.4 million residential customers and 140,000 small commercial and industrial customers were transferred from standard offer service to basic service.

As the table below illustrates, significant gains in the percent of electricity consumption purchased through competitive supply have been realized since the end of standard offer service in February 2005. Between February and April 2005 (the most recent date for which electric customer migration data are available), the electricity consumption purchased by large commercial and industrial ("C&I") customers from the competitive market has increased by 20 percent. The electricity consumption purchased by medium C&I customers from the competitive market has increased by 34 percent during this same period. The percent increases for small C&I and residential customers have been even greater.

² Certain of the gains for small C&I and residential customers are likely attributable to an expansion of the municipal aggregation program managed by the Cape Light Compact in Commonwealth Electric Company's service territory. The Cape Light Compact has implemented a municipal aggregation plan available to all customers in the Towns of Aquinnah, Barnstable, Bourne, Brewster, Chatham, Chilmark, Dennis, Edgartown, Eastham, Falmouth, Harwich, Mashpee, Oak Bluffs, Orleans, Provincetown, Sandwich, Tisbury, Truro, West Tisbury, Wellfleet, and Yarmouth. The Cape Light Compact's municipal aggregation program currently has approximately 200,000 participants. Even when the impact of expanded municipal aggregation is removed, electricity consumption purchased by small C&I customers from the competitive market has increased by nine percent.







The Department of Telecommunications and Energy ("DTE") is actively involved in an ongoing effort to ensure that the benefits of the competitive market accrue to all Massachusetts ratepayers. On June 20, 2005, the DTE held an all-day forum to discuss the procurement of basic service for smaller customers. Chairman Paul G. Afonso, along with Commissioners James Connelly, W. Robert Keating, and Judith F. Judson engaged over 50 industry participants and customer representatives in discussion of how the DTE's current basic service procurement policies could be modified and what steps the DTE could take to ensure that the benefits of the competitive market accrue to all Massachusetts ratepayers.

At the forum, participants including representatives from the electric distribution companies, competitive electric suppliers, Attorney General, Division of Energy Resources, Associated Industries of Massachusetts, Union of Concerned Scientists, and Conservation Law Foundation discussed what steps the DTE could take to increase the competitive options for residential and small C&I customers. As a follow-up to the forum, interested persons were invited to submit written comments to the DTE.

The DTE has also been involved with the Associated Industries of Massachusetts, participating in a series of educational seminars and supplier forums throughout Massachusetts over the past several months. These forums are designed to give small, medium, and large C&I customers an opportunity to meet with licensed competitive electricity suppliers and brokers directly.

Attachment 1 shows all competitive electricity suppliers and brokers licensed in Massachusetts and the DTE has seen an increase in license applications in recent months. While not all suppliers and brokers are currently actively marketing to residential customers, there are a range of competitive choices available to C&I customers. For example, in Massachusetts Electric Company's service territory, eleven competitive suppliers and 20 electricity brokers are actively marketing to C&I customers (<u>http://www.nationalgridus.com/</u>masselectric/business/energychoice/4_supplier_list.asp).

Consistent with our legislative mandate, the DTE is committed to taking all appropriate and reasonable steps to ensure the successful implementation of retail competition in Massachusetts. We will continue to report on future market developments.
