CONSENT AGREEMENT FOR PROBATION

The Massachusetts Board of Registration in Pharmacy ("Board") and Stephany Jayne Leurini ("Licensee"), PH233685, do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Licensee's record maintained by the Board:

- 1. Licensee acknowledges that the Board opened a complaint against her Massachusetts pharmacist license related to the conduct set forth in Paragraph 2, identified as Docket No. PHA-2016-0101.1
- 2. The Board and Licensee acknowledge and agree to the following facts:
 - a. On or about March 25, 2016, Licensee worked as a pharmacist at CVS Pharmacy # 1257 ("Pharmacy"), DS1963, located in East Bridgewater, Massachusetts.
 - b. On or about March 25, 2016, a Board Investigator inspected the Pharmacy. During the inspection and subsequent investigation, the Investigator observed that Licensee compounded and dispensed Neosporin in sodium chloride intended for bladder irrigation under insanitary conditions, in violation of United States Pharmacopeia Chapter 797 and 247 CMR 9.01(3). Additionally, Licensee assigned a beyond use date to said medication in excess of the manufacturer's package insert recommendation.

- 3. The Board and Licensee acknowledge and agree that Licensee's conduct described in Paragraph 2 is a violation 247 CMR 9.01(3) and United States Pharmacopeia Chapter 797 and warrants disciplinary action by the Board under M.G.L. c. 112, §§ 42A & 61 and 247 CMR 10.03(1)(v).
- 4. Licensee agrees that her pharmacist license shall be placed on PROBATION for 2 years ("Probationary Period"), commencing with the date on which the Board signs this Agreement ("Effective Date").
- 5. During the Probationary Period, the Licensee further agrees that she shall comply in all material respects with all laws and regulations governing the practice of pharmacy and the United States Pharmacopeia.
- 6. The Board agrees that in return for Licensee's execution and successful compliance with the requirements of this Agreement it will not prosecute the Complaint.
- 7. If the Licensee has complied to the Board's satisfaction with all the requirements contained in this Agreement, the Probationary Period will terminate 2 years after the Effective Date upon written notice to the Licensee from the Board².
- 8. If the Licensee does not materially comply with each requirement of this Agreement, or if the Board opens a Subsequent Complaint³ during the Probationary Period, the Licensee agrees to the following:
 - a. The Board may upon written notice to the Licensee, as warranted to protect the public health, safety, or welfare:
 - i. EXTEND the Probationary Period; and/or
 - ii. MODIFY the Probation Agreement requirements; and/or

² In all instances where this Agreement specifies written notice to the Licensee from the Board, such notice shall be sent to the Licensee's address of record.

³ The term "Subsequent Complaint" applies to a complaint opened after the Effective Date concerning acts, omissions, or events occurring after the Effective Date, which (1) alleges that the Licensee engaged in conduct that violates Board statutes or regulations, and (2) is substantiated by evidence, as determined following the complaint investigation during which the Licensee shall have an opportunity to respond.

- The Licensee acknowledges that she has been at all times free to seek 11. and use legal counsel in connection with the Complaint and this Agreement.
- The Licensee acknowledges that after the Effective Date, the 12. Agreement constitutes a public record of disciplinary action by the Board. The Board may forward a copy of this Agreement to other licensing boards, law enforcement entities, and other individuals or entities as required or permitted by law.
- The Licensee certifies that she has read this Agreement. The Licensee 13. understands and agrees that entering into this Agreement is a voluntary and final act and not subject to reconsideration, appeal or judicial review.
