DECISION

LANPHERS MARKET LLC D/B/A LANPHERS MARKET
240 REDEMPTION ROCK TRAIL
STERLING, MA 01564

Lanphers Market LLC d/b/a Lanphers Market (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 13, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

1. Investigator Doyle's Compliance Check Field Report dated April 20, 2016; and
 2. Licensee's Stipulation of Facts.

The Commission took Administrative Notice of the Licensee's record.


FACTS

1. On Wednesday, April 20, 2016, at approximately 5:30 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business operation of Lanphers Market LLC d/b/a Lanphers Market.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 16 oz. can of Budweiser Light beer, for one dollar and eighty-five cents (\$1.85). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
