

Project Location

Interstate 90 in West Stockbridge / Stockbridge (Mile Marker 0.0 to Mile Marker 7.8)







- Resurfacing a portion on Interstate 90 through West Stockbridge and Stockbridge from *MM 0.0 to MM 7.8.
- Work primarily consists of milling and resurfacing the mainline, bridge decks, transitions to / from bridge decks, including entry and exit ramps, pull offs, and turnarounds.
- Related work includes bridge improvements; upgrading non-compliant guardrail and end treatments as
 required; clearing and grubbing; stormwater improvements including cleaning, capping, reconstructing, and
 installing new paved waterways as proposed and/or required; adjusting, rebuilding, and cleaning out drainage
 structures; replacing damaged frames and grates/covers, and upgrading non-compliant drainage structures
 within the traveled way with locking frames and grates/covers; resetting granite edging; replacing hot mix
 asphalt berm; installing temporary and permanent pavement markings with new slotted pavement markers;
 installing milled rumble strips; and implementing all safety controls and signing required for the necessary work
 zones.

Purpose & Need/Traffic Impacts

Purpose & Need

- Existing pavement has degraded to a poor level and requires resurfacing. Resurfacing will improve the pavement serviceability, condition, and roadway safety.
- Superstructures and piers of bridges have deteriorated and require routine maintenance work.

Traffic Impacts

- Lane shifting will have minor impacts to the overall traffic pattern.
- One lane of traffic in each direction will be maintained at all times.
- The proposed schedule for nighttime operations shall be a 10-hour day, 5-day week. The work shall be conducted between the approved hours of 7:00 PM and 5:30 AM unless otherwise authorized by the Engineer and with certain exceptions for holidays.
- Construction will take approximately two years to complete.

- Bid Opening was January 9, 2024
