**DECISION**

**GANGLANI CORPORATION DBA REDSTONE LIQUORS**  
**109 MAIN STREET**  
**STONEHAM, MA 02180**  
**LICENSE#: 124200016**  
**HEARD: 06/26/2012**

Ganglani Corporation dba Redstone Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 26, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Capurso's Compliance Check Field Report.

The following items are in evidence:

1. Licensee's Stipulation of Facts; and
2. Investigator Capurso's Compliance Check Field Report dated April 9, 2012.
  - A. W4 Tax Form for Employee Who Served the Minor; and
  - B. Payroll for Same Employee Who was Terminated.

There is one (1) audio recording of this hearing.

FACTS

1. On Monday, April 09, 2012 at approximately 07:00 p.m., Investigators Temple and Capurso conducted an investigation of the business operation of Ganglani Corporation dba Redstone Liquors.
2. An underage operative working with investigators purchased an alcoholic beverage, a can of Heineken beer for two dollars and seventy-five cents (\$2.75). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2), to wit: M.G.L. c. 138, §34. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.


