## **DECISION**

MOON GLOW RESTAURANT, INC. D/B/A CHINA MOON RESTAURANT 170 MAIN ST.

STONEHAM, MA 02180 LICENSE#: 124200005

**VIOLATION DATE: 05/13/2016 HEARING DATE: 10/25/2016** 

Moon Glow Restaurant, Inc. d/b/a China Moon Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 25, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report dated May 13, 2016; and
- 2. Licensee's Stipulation of Facts.
- A. List of Licensee's Employees with TIPS Training.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Friday, May 13, 2016, at approximately 7:20 p.m., Investigators Di Cicco and Keefe investigated the business operation of Moon Glow Restaurant, Inc. d/b/a China Moon Restaurant.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Budweiser Light beer for four dollars and fifty cents (\$4.50). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business over 30 years and has had no previous violations, the Commission issues a **WARNING**.
