Radhe LLC d/b/a Center Beverage (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, August 6, 2019, regarding an alleged violation of 204 CMR 2.05 (2)-Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact; and
- 3. Licensee's License Application.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Saturday, April 13, 2019, at approximately 7:48 p.m., Investigators Di Cicco and Keefe ("Investigators") investigated the business of Radhe LLC d/b/a Center Beverage.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer for three dollars (\$3.00). The underage operative was not asked for identification.
- 3. The Licensee has been licensed under M.G.L. c. 138, § 15 since 2013 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated of 204 CMR 2.05 (2)-Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21). Therefore, the Commission issues a WARNING.
