Three Chefs, Inc. d/b/a Ailaa Himalayan Bar and Grill ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Bolcome and Anderson's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Bolcome and Anderson's Minimum Purchase Age Compliance Check Field Report, 5/10/2023;
- 2. Licensee's Stipulation of Facts;

### FINDINGS OF FACT

- 1. On Wednesday, May 10, 2023, at approximately 6:32 p.m., Investigators Bolcome and Anderson ("Investigators") conducted a compliance check at Three Chefs, Inc. d/b/a Ailaa Himalayan Bar and Grill.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one Corona beer, for five dollars (\$5.00). The underage operative was not asked for identification.

3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2023 with no prior violations.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
