DECISION

ANDRADE BROTHERS, INC. DBA ANDRADE LIQUORS 280 WASHINGTON ST STOUGHTON, MA 02072 LICENSE#: 124400044

Andrade Brothers, Inc. dba Andrade Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 8, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age.

Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kenny's Report.

FACTS

- 1. On April 22, 2013 at approximately 5:20 p.m., Investigators Teehan and Kenny conducted an investigation of the business operation of Andrade Brothers, Inc. dba Andrade Liquors.
- 2. An underage operative working with investigators purchased an alcoholic beverage. The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one

(21) years of age. The licensee has been in business for ten (10) years and has no prior violations. Therefore, the Commission issues a **WARNING**.
