## MEMORANDUM AND ORDER ON LICENSEE'S REQUEST FOR RECONSIDERATION

CLUB LUIZ DE CAMOES INC. 76 PORTER STREET STOUGHTON, MA 02072 LICENSE#: 00008-CL-1244

Club Luiz De Camoes Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "ABCC" or "Commission") held a hearing on Wednesday, October 28, 2020 regarding alleged violations of:

- 1) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Massachusetts Executive COVID-19 Order No. 37 (June 6, 2020) Violation of sector specific workplace safety standards for restaurants to address COVID-19;
- 2) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Massachusetts Executive COVID-19 Order No. 40 (June 19, 2020) Violation of sector specific workplace safety standards for restaurants to address COVID-19;
- 3) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Violation of Mass. Exec. COVID-19 Order No. 54 (Nov. 2, 2020);
- 4) 204 CMR 2.05(2)- Permitting an illegality on the licensed premises, to wit: Mass. Exec. COVID- 19 Order No. 55 (Nov. 2, 2020) Patron or employee failing to wear a mask or cloth face covering over their mouth and nose when in a public location.

By decision dated December 15, 2020 the Commission found the Licensee in violation of the charges and indefinitely suspended the License effective forthwith until further written order from this Commission.

The Commission stated that it would consider issuing a further order upon written request of the Licensee showing good cause to reconsider this indefinite suspension. Good cause for the Commission would include, but not be limited to, the Licensee's receiving approval from the Massachusetts Department of Labor Standards ("DLS") as to a reopening plan.

On January 27, 2021, the Licensee submitted a written request to reconsider the indefinite suspension. On February 2, 2021, the Commission received the notice of approval from Massachusetts Department of Labor Standards ("DLS").

4. Provide photos and documents to DLS in an email

- a. Copy of Menu
- b. Copy of signage for customers (face coverings, distancing)
- c. Photos of table layout and seating so that distancing is maintained
- d. A signed roster that all staff has been trained on the <a href="https://www.mass.gov/doc/sector-specific-workplace-safety-standards-phase-iii-step-1-for-restaurants-to-address-covid-1/download">https://www.mass.gov/doc/sector-specific-workplace-safety-standards-phase-iii-step-1-for-restaurants-to-address-covid-1/download</a> -
- e. A copy of the visitor log template sign in sheet for contact tracing
- f. Photos of counter seating at bar so that customer groups are distanced, and the staff are distanced from customers
- g. Live music: at this time, live music performance is not allowed in COVID protocols.
- h. Event rentals: if you rent portions of your facility for events, you are required to follow the capacity limits in the Indoor/Outdoor Event Standard.
- Copy of cleaning schedule
- j. Copy of cleaning products being used
- 5. DLS will contact you if additional information is needed. This is often the case. The DLS inspector works with you to develop a plan that complies with requirements.
- 6. DLS will provide a written letter with our findings to ABCC when the DLS review yields satisfactory implementation of the COVID safety plan.
- 7. Send an email to ABCC asking for consideration for reinstatement. This is the last step, but you are able to send this early. ABCC will not act on your request until they receive a letter of satisfaction from DLS. Email ABCC at <a href="mailto:phathaway@tre.state.ma.us">phathaway@tre.state.ma.us</a>
- 8. When ABCC receives all material, they will review your information. ABCC is the agency that notifies you if the license is reinstated.
