NOTICE OF SUSPENSION

December 16, 2015

After a hearing on December 15, 2015, the Commission finds Nalli Enterprises Inc. d/b/a The Last Shot violated 204 C.M.R. 2.05 (2) Permitting an illegality on the licensed premises to wit; M.G.L. c. 138, §34C – Possession of an alcoholic beverage by a person under twenty- one (21) years of age (2 Counts).

The Commission suspends the license for six (6) days of which three (3) days will be served and three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.

The suspension shall commence on Wednesday, February 3, 2016, and terminate on Friday, February 5, 2016. The license will be delivered to the Local Licensing Board or its designee on Wednesday, February 3, 2016 at 9:00 A.M. It will be returned to the licensee on Saturday, February 6, 2016.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

**DECISION**

Nalli Enterprises Inc. d/b/a The Last Shot holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 15, 2015, regarding an alleged violation of 204 C.M.R. 2.05 (2) Permitting an illegality on the licensed premises to wit; M.G.L. c. 138, §34C – Possession of an alcoholic beverage by a person under twenty- one (21) years of age (2 Counts). Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Teehan's Report.

The following documents are in evidence:

1. Investigator Teehan's Investigative Report dated September 28, 2015;
2. Licensee's Stipulation of Facts;
3. Printout of Massachusetts Driver's License for Underage Female 1;
4. Printout of Massachusetts Driver's License for Underage Female 2; and
5. Photocopy of two (2) Fraudulent Connecticut Driver's Licenses.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

**FACTS**

1. On Friday, September 18, 2015 at approximately 11:45 p.m., Investigators Teehan and Kenny ("Investigators") conducted an investigation of the business operation of Nalli Enterprises Inc. d/b/a The Last Shot to determine the manner in which the business was being conducted.


2. While on the licensed premises, Investigators observed two female subjects in possession of alcoholic beverages.
3. Underage Female 1 was later identified and has a real date of birth of 8/16/1995 (20 years-old).
4. Underage Female 2 was later identified and has a real date of birth of 2/2/1995 (20 years-old).
5. Underage Female 1 was observed being in possession of a Red Bull with Vodka.
6. Underage 1 stated to Investigators that she used a fake Connecticut Driver's license to enter the licensed premises bearing her own name but with a date of birth of 8/16/1993 (22 years-old).
7. Underage Female 2 was observed being in possession of a Corona Extra beer.
8. Underage Female 2 stated to Investigators that she used a fake Connecticut Driver's license to enter the licensed premises bearing her own name but with a date of birth of 2/2/1994 (21 years- old).
9. Investigators informed the manager on duty later identified as Michelle Nally of the violations and that a report would be filed for further action.

#### CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 C.M.R. 2.05 (2) Permitting an illegality on the licensed premises to wit; M.G.L. c. 138, §34C -- Possession of an alcoholic beverage by a person under twenty- one (21) years of age (2 Counts). Therefore, the Commission **suspends the license for six (6) days of which three (3) days will be served and three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
