Boyzzi, Inc. dba Rovezzi's Restaurant (the "Licensee") holds an all alcohol license issued. pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Thursday, December 8, 2011, regarding an alleged violation of M.G.L. c.151A, §14. The licensee failed to appear at the hearing or request a continuance of the matter by the Commission. By decision dated November 22, 2011, the Commission INDEFINITELY SUSPENDED the license of Boyzzi, Inc. dba Rovezzi's Restaurant effective DECEMBER 1, 2011, until further written order of the Commission. The Commission held that it would not issue any further order without a written request from the licensee showing good cause to reconsider this indefinite suspension and a hearing before the Commission that the licensee attends.

The licensee filed a written request to reconsider the indefinite suspension. The licensee attended a hearing before the Commission and argued that good cause exists to reconsider the indefinite suspension.

CONCLUSION

Based on the evidence, the Commission reconsiders and reverses its prior order of INDEFINITE SUSPENSION of Boyzzi, Inc. dba Rovezzi's Restaurant's license effective **DECEMBER 8, 2011.**

Therefore, the Commission orders a further hearing on this matter to be held on THURSDAY, JANUARY 12, 2011 at 9:30 AM. The licensee is cautioned that failure to appear at this hearing or failure to comply with its obligations to pay to the DUA may result in the termination of this license.
