DECISION

G & L GROUP LLC D/B/A TRAIL DUSTERS 139 MAIN STREET, UNIT 2 STURBRIDGE, MA 01566 LICENSE#: 08614-RS-1248

VIOLATION DATE: 5/21/2025

HEARD: 9/02/2025

G & L Group LLC d/b/a Trail Dusters ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 2, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators David and Temple's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

- 1. On Wednesday, May 21, 2025, at approximately 8:33 p.m., Investigators David and Temple ("Investigators") conducted a compliance check at G & L Group LLC d/b/a Trail Dusters.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a Coors Light beer, for five dollars and thirty-five cents (\$5.35). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2024.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
