**DECISION**

**T.T.S. TRIO CORPORATION DBA KAIZEN RESTAURANT**  
**479 MAIN STREET**  
**STURBRIDGE, MA 01566**

T.T.S Trio Corporation dba Kaizen Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 17, 2014, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Keefe's Report.

  2. Investigator Keefe's Compliance Check Field Report dated March 19, 2014.

**FACTS**

1. On Wednesday, March 19, 2014, at approximately 6:17 p.m., Investigators Temple and Keefe conducted an investigation of the business operation of T.T.S Trio Corporation dba Kaizen Restaurant.
2. An underage operative, working with investigators, purchased an alcoholic beverage, a container of Budweiser Light beer for three dollars and fifteen cents (\$3.15). The underage operative was not asked for identification.



### CONCLUSION


Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission **suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
