





 - Consumer success is based on "Timely Progress"





What is an Administrative EN?

An Administrative Employment Network is an association of providers organized under an EN of Record to combine their resources to function as a single EN to provide appropriate employment, vocational rehabilitation, or support services to beneficiaries with disabilities

The Work Without Limits AEN

The WWL AEN partners with Community-Based Organizations (CBOs) enabling them to receive payments through Social Security's <u>Ticket to Work (TTW) program</u> while providing the individuals they serve with detailed benefits counseling designed to help them reach their employment goals. The WWL AEN provides

- TTW assignment and payment processing
- TTW payment share with partnering organizations
- Enhanced benefits counseling and ongoing support for individuals who are working or planning to go to work
- Technical assistance and overview training for staff on the impact of working on public benefits
