All treatment, from the intake, to the discharge was under my direction. My responsibilities included oversight of individual therapy, group therapy, and family therapy for the youth in the program and their families. Other responsibilities included supervision of two residential clinicians, and meeting the policy requirements of the Department of Youth Services. I helped implement new treatment modalities into the milieu, such as Positive Youth Development, and Attachment, Regulation and Competency. Creating and maintaining a Trauma Informed Environment was also under my oversight.

I engaged in individual therapy, group therapy and family therapy. I also provided crisis management and assisted in developing new programs at the agency, such as Trauma Informed Care.
