Summary of Updates to the MassDEP Estimated Sewer System Service Area Boundaries Dataset

MassDEP's Water Utility Resilience Program (WURP) continues to maintain and enhance the quality of the **Estimated Sewer System Service Area Boundaries** published via MassGIS. This document provides a summary of updates included in the most current version of the data. Additional documentation describing the dataset, including data sources and verification processes, are available in the **metadata**. Data Updates

In 2024, MassDEP began a joint federal partnership with the United States Geological Society (USGS). Under this agreement, USGS worked with MassDEP staff in updating service areas not previously confirmed. As described in Table 1 (below), the data quality has improved through confirmation of additional polygons representing areas served by publicly-owned treatment works (POTWs) and private treatment works (non-POTWs). In total, the current dataset (PubV2025_10) confirmed 269 of 333 POTW service areas delineated and 116 of 280 non-POTW service areas delineated. This represents an increase of 16% POTWs and 13% non-POTWs in service areas confirmed compared to the previous publication (PubV2024_12).

USGS also developed a methodology and an automated process to create statistics for the number and percent of developed parcels within each of the service areas. These statistics have been added to service areas with facility type "POTW" and sector type "Municipal/Regional/District". See the metadata for detailed description and calculation methods for percent statistics. For these same types of POTW service areas, information has also been added to each feature to describe the number of POTW systems servicing the municipality, how the service area originated, additional sewer areas in that municipality, and whether the POTW overlaps other towns. Updates made during this period (October 2024 to October 2025) are reflected in a version referenced as MassDEP, Water Utility Resilience Program. 2025.
