In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department"), has designated me the Final Decision-Maker in this administrative appeal.¹

I have reviewed and hereby approve the attached Settlement Agreement by Administrative Consent Order with Penalty and Notice of Noncompliance executed on March 1, 2020, by Sunil Patel, representative for the Petitioner, Sunny's Convenience, and on March 5, 2020 by Richard Blanchet, Deputy Division Director of Hazardous Materials Management for the Massachusetts Department of Environmental Protection ("the Department" or "MassDEP") (ACOP 00009317), to settle this appeal.
