I have been placed on probation by this court. I will follow the conditions of probation ordered by the court. Beginning in the second year of my release on probation to the community, if I comply with these conditions I will earn credits each month toward shortening my probation term, at a rate of 5 days per month in my second year of probation and 10 days per month in my third and any subsequent years. G.L. c. 276, § 87B. If I violate these conditions, I may lose compliance credits.

## GENERAL CONDITIONS OF PROBATION

1. I will obey all court orders and all local, state, and federal laws.
2. I will maintain contact with my probation officer as directed and will report to my probation officer at such times and places as required. The probation department can be contacted at: \_\_\_\_\_.
3. I will sign all releases necessary for supervision and verification of compliance with these conditions.
4. I will inform my probation officer immediately of a change of residence or employment and will inform my probation officer at each scheduled appointment where I am residing. If I am incarcerated, I will report to the probation department within 48 hours after my release or on the next business day following a weekend or court holiday.
5. I will allow the probation department to visit me in my home or elsewhere.
6. I will not leave Massachusetts unless I receive permission from my probation officer or the court.
