SHRIJI VARIETY ONE LLC D/B/A SUTTON CENTER COUNTRY STORE 3 SINGLETARY AVENUE SUTTON, MA 01590

Shriji Variety One LLC d/b/a Sutton Center Country Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 8, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: Ch. 138 § 34 — Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple & David's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Temple & David's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 9/11/2020;
- 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

- 1. On Tuesday, April 29, 2025, at approximately 7:46 p.m., Investigators David and Temple ("Investigators") conducted a compliance check at Shriji Variety One LLC d/b/a Sutton Center Country Store.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one can of White Claw Mango for three dollars and sixty-nine cents (\$3.69). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2020.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
