NHI Inc. d/b/a Swansea Mobil ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 27, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Keefe & Fleming's Report.

FINDINGS OF FACT

- 1. On Monday, April 10, 2023, at approximately 4:52 p.m., Investigators Fleming and Keefe ("Investigators") conducted a compliance check at NHI Inc. d/b/a Swansea Mobil.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce Bud Light beer, for three dollars and thirty cents (\$3.30). The underage operative was not asked for identification.
- 3. Najib Ayoub, Licensee, appeared at the Commission hearing. The Commission was informed the Licensee's policy at the time of the compliance check was to request

identification from any patrons who appear to be 35 years of age or younger. The Licensee has instituted a new policy wherein all patrons are now required to produce identification.

4. The Licensee has held a license under M.G.L. c. 138, § 12 since 2015 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
