**Subject:** TAA Program Changes Resulting from the Enactment of the Trade

**Adjustment Assistance Reauthorization Act of 2015** 

## **Purpose:**

To notify Local Boards, One Stop Career Center Operators, and other Local Workforce and Economic Development partners of implementation of the Trade Adjustment Assistance Reauthorization Act of 2015 (TAARA). TAARA repeals the sunset provisions of the Trade Adjustment Assistance Extension Act of 2011 (TAAEA) and reauthorizes the Health Coverage Tax Credit (HCTC) retroactive back to January 2014.

States have 90 days to implement the transition of benefits and services under the 2015 Program provisions to Reversion 2014 participants. States will continue to administer the Reversion 2014 Program benefits, including ATAA, to workers covered under petition series 85,000 through 89,999, through September 27, 2015; and will administer 2015 Program benefits and services to those workers certified under the Reversion 2014 Program beginning Monday, September 28, 2015.

Changes to the Massachusetts One-Stop Employment System (MOSES) and UI Online are being prepared. Once the Office of Trade Adjustment Assistance issues operational guidance more information will be sent under separate cover.

Background: The Trade Adjustment Assistance (TAA) program provides benefits and support to

U.S. workers who become unemployed due to the impact of international trade. On June 29, 2015, President Obama signed into law the Trade Adjustment Assistance Reauthorization Act of 2015, which continues the TAA program for six years, and changes the group eligibility requirements and individual benefits and services available under the Trade Adjustment Assistance Extension Act of 2011's sunset provisions from January 1, 2014.
