**OVERVIEW**

In accordance with the Commissioner of Public Health’s COVID-19 Public Health Emergency Order 2021-6 issued on August 26, 2021, current EMS providers certified in other states, or previously holding Massachusetts certification may apply and be issued temporary certifications to practice in Massachusetts.

MDPH/OEMS will review and verify your eligibility for certification. Only those candidates who meet **ALL** eligibility requirements will be eligible for this temporary certification. Applications will be returned to those candidates who are not eligible for certification. Please fill out both sides of the form completely and legibly. Sign and date the application form as testimony that all the information presented is accurate to the best of your knowledge.

There is no fee for this application or temporary certification. Current National Registry of EMTs (NREMT) certification is NOT required.

At the expiration of the temporary period, certifications issued under this order will no longer be valid. Individuals who were given temporary EMT certification who then wish to become fully EMT certified must follow the standard process and meet all requirements for certification.

**ELIGIBILITY:**

In accordance with the Commissioner of Public Health’s COVID-19 Public Health Emergency Order 2021-6 issued on August 26, 2021, the Department may issue certification to:

- EMS providers who are **currently** licensed/certified in another state in good standing, upon verification the other state’s credential is in good standing; **OR**
- Individuals who have held Massachusetts EMT certification previously, which has expired **within the past ten years**.

**APPLICATION CHECKLIST**

- CPR CARD** A copy of **both sides** of your current Basic Cardiac Life Support (**BCLS**) card or equivalent, provided by a nationally recognized organization and reflecting current cardiopulmonary resuscitation (CPR) and emergency cardiac care resuscitation science and treatment recommendations issued by the International Liaison Committee on Resuscitation (ILCOR)’s standards. Course must include in person-hands on training and skills evaluation.
- ACLS CARD (FOR PARAMEDICS)** A copy of **both sides** of your current Advanced Cardiac Life Support (**ACLS**) card provided by a nationally recognized organization and reflecting current cardiopulmonary resuscitation (CPR) and emergency cardiac care resuscitation science and treatment recommendations issued by the International Liaison Committee on Resuscitation (ILCOR)’s standards. Course must include in person-hands on training and skills evaluation.
- STATE VERIFICATION FORM** **Only if you have current or expired EMS certification in any other state.** This form is available online and must be completed for any state in which you have (or held) EMT certification/licensure (at any level). Send this form to the State EMS office of question and they will return it directly to our office.
- CORI PACKET** **Only if you answer “YES” to QUESTION 4 (criminal history).** Form available at [mass.gov/dph/oems](http://mass.gov/dph/oems).

I authorize MDPH/OEMS and its staff to contact the Criminal History Systems Board for access to conviction and pending criminal case data, as well as to contact other agencies as may be necessary to verify information related to this application. As an applicant for certification or recertification or as an EMT, I understand that a criminal history check may be conducted and that it will not automatically disqualify me.
- 6. I hereby certify that I meet all the criteria for certification as required by 105 CMR 170.000 et seq. Further, I certify under the penalty of perjury that the information contained in this application is correct and I acknowledge that any false, inaccurate, or omitted statement or document is grounds for denial, revocation or suspension of the certification which I am seeking to gain.
