


On October 18, 2023, the Massachusetts Appeals Court and the Justice Harry J. Elam Judicial Conference (formerly known as the Massachusetts Black Judges Conference) unveiled a portrait of the Honorable Frederick L. Brown, retired Justice of the Appeals Court, to be displayed in the Allan M. Hale Courtroom. Justice Brown was joined on the bench by Chief Justice Mark V. Green, speaking on behalf of the Appeals Court, Associate Justices Peter J. Rubin and Gabrielle R. Wolohojian, speaking as colleagues and friends, Associate Justice Kenneth V. Desmond, Jr., Master of Ceremonies and President of the Justice Harry J. Elam Judicial Conference, and Associate Justice Diana L. Maldonado (ret.), speaking as a former law clerk to Justice Brown. Distinguished speakers contributed remarks regarding the momentous career and legacy of Justice Brown, a thorough and adept jurist and the first African American to reach the Massachusetts appellate bench.

Many dignitaries from the judiciary, former law clerks to Justice Brown, including **Honorable Raheem L. Mullins** of the Connecticut Supreme Judicial Court, and members of the Legislature and


In October and November, the Appeals Court traveled far and wide to conduct
