## Project Construction Update



### *Underground Utility Work*

#### What is Happening?

- The contractor is scheduled to perform water pipe replacement work as part of the Springfield 'X' Intersection Reconstruction project.
- Activities will include asphalt removal, excavation, trenching, water line installation, material deliveries, exporting material, staging of construction equipment, and asphalt restoration.

#### What to Expect?

- **Temporary water service interruptions for individual properties are expected on Belmont Avenue and Commonwealth Avenue.** Notifications for specific properties, dates, and times will be provided in coordination with the Springfield Water and Sewer Commission. - There will be intermittent lane closures on Belmont Avenue between Sumner Avenue and Ormond Street, and on Commonwealth Avenue between Belmont Avenue and Walden Street, during work hours. Local access for residents, businesses, and emergency services will be maintained.
- Police details and appropriate signage will be deployed to assist traffic flow around the work zones.
- On-street parking restrictions are anticipated due to site safety and staging of equipment.

#### Where is this Work Happening?

This work is anticipated to take place on:

- Belmont Avenue between Sumner Avenue and Ormond Street.
- On Belmont Avenue at the Sumner Avenue, Commonwealth Avenue, and Ormond Street intersections.
- On Commonwealth Avenue, between Belmont Avenue and Walden Street.

#### When is this Work Happening?

- Work is anticipated to start **Monday, August 4** and continue through **Fall 2025**.
- Work is scheduled on weekdays, **Monday – Friday, from 7:00 a.m. – 3:30 p.m.**
- Water line work in other areas of the project limits will be scheduled at later dates.
