**RE:** Prior Authorizations Submitted by Therapist Group Practices

Claim Denials for Provider Number on Claim and PA Mismatch (Error Code 159) This bulletin clarifies MassHealth requirements of therapist group practices for requesting prior authorization (PA) for therapy services. Therapist group practices requesting PA must submit a request under the *individual* independent therapist's MassHealth servicing provider number, and not under the group practice number. If you have requested a PA using the Automated Prior Authorization System (APAS), and received the PA approved under your group practice provider number, any claims for dates of service **on and after April 15, 2004**, may have been denied with error code 159, indicating that the provider number on the claim and the provider number on the PA do not match.

#### Correcting PAs

MassHealth has developed a process for correcting PAs that were submitted through APAS and authorized under the therapy group practice provider number (provider number beginning with 97). If you have claims that have been denied with error code 159, with dates of service **on or after April 15, 2004**, you can contact the MassHealth Prior Authorization Unit at 617-451-7060 to request that a new PA be issued with the appropriate individual independent therapist provider number. When you contact the PA Unit, you must provide:

- the original PA number of each PA that needs to be reissued; and
- the appropriate independent therapist's provider number for each PA that needs to be reissued.

Once you receive notice that a new PA has been issued, you will be able to resubmit your otherwise payable claims using the new PA numbers on your claims. You should follow MassHealth standard procedures for resubmitting claims, and make sure that you correct any other errors that may have caused the claim to deny. #### Future PA Submissions

# **Submitting Requests Using APAS**

To ensure that PA requests for therapy services submitted through APAS are authorized with the independent therapist's provider number, group practice providers must contact the MassHealth APAS administrator, Ancillary Care Management (ACM), at 1-866-378-3789, and give ACM a list of the MassHealth provider numbers for all independent therapists that work for the group. Providers must remember to contact ACM any time a new independent provider is added to the group as a MassHealth provider.

## **Submitting Requests on Paper**

Therapy group practice providers who submit PA requests on paper must enter the independent therapist's provider number in Item no. 3 of the Prior Authorization Request form.
