Probation's Halloween Supervision Efforts Enhance Public Safety

Hampden Superior, Fall River District, and Essex County Probation Officers worked on Halloween night to ensure the safety of the community.

The Hampden and Fall River Probation Officers checked on sex offenders to make sure they were not coming into contact with children as part of the "Operation Lights Out" initiative first introduced in the Service nearly a decade ago by Fall River District Court Probation Officer Michael Borden. Borden was inspired by a similar effort he read about in the Midwest.

Four Hampden PO's—POII Rosa Maldonado-Brown and Probation Officers Allison Hayden, Tyena Whitley, and Michele Rogers— made unannounced visits to the Springfield homes of 15 probationers to and were not displaying any lighting or décor that would attract trick or treaters to their doors.

In Fall River, where "Operation Lights Out" was first launched, Probation Officers Borden, Mark Costa, and Arcary Dominguez teamed up with local police, including the Fall River Police's Special Operations Unit and Swansea and Somerset police. They visited the homes of 30 sex offenders.

Across the state, in Essex County, another group of Probation Officers joined forces with law enforcement officers—including Homeland Security, Parole, state and local police—to maintain public safety at Salem's Haunted Happenings, one of America's largest Halloween celebrations. The team assisted with crowd control and kept an eye out for probationers.
