**DECISION** 

CHANCHETHA CORP. D/B/A THE WINE NOOK 18 MAIN STREET TOWNSEND, MA 01469 LICENSE#: 00010-PK-1286 VIOLATION DATE: 7/29/2019 HEARD: 10/15/2019

Chanchetha Corp. d/b/a The Wine Nook (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 15, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Doyle's Report.

## FACTS

- 1. On Monday, July 29, 2019, at approximately 5:14 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business of Chanchetha Corp. d/b/a The Wine Nook.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer for one dollar and eighty cents (\$1.80). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2007 with two prior violations in 2013 and 2014.

## **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a WARNING.
