

Toxics Use Reduction Act (TURA) Services for Massachusetts Businesses



The Toxics Use Reduction Act (TURA) is implemented jointly by the Massachusetts Department of Environmental Protection (MassDEP), the Office of Technical Assistance and Technology (OTA), and the Toxics Use Reduction Institute (TURI). OTA and TURI provide a range of services to help Massachusetts businesses reduce toxics, save energy and water, and improve competitiveness. All of these services are available free of charge.

Office of Technical Assistance and Technology (OTA)

OTA is a non-regulatory agency within the Executive Office of Energy and Environmental Affairs that provides free, confidential, on-site technical and compliance assistance to manufacturers, businesses and institutions. These services are available free of charge to all Massachusetts businesses.

OTA can help your company to:

- Manage and reduce air releases, water discharges, hazardous waste generation and toxic chemical use and chemical waste.
- Prevent accidents and reduce liability associated with the use of toxics.
- Reduce costs by improving manufacturing processes and identifying alternative materials.
- Reduce energy and water bills.
- Find useful products and services to enhance your business and environmental sustainability.

A company that wants to share their success in reducing toxics can also work with OTA to prepare a short case study for public distribution.

OTA has helped hundreds of companies to save money, reduce pollution, and stay in compliance with environmental regulations.

- Ask for an OTA visit. Seeing your operation allows OTA staff to better understand what your options might be. Companies visited by OTA have achieved significant reductions in energy use, water use and the use and releases of toxic chemicals, while saving money.

Toxics Use Reduction Institute (TURI)

The Toxics Use Reduction Institute (TURI), at the University of Massachusetts Lowell, provides education and training; sponsors research into the development of cleaner, safer materials and technologies; provides grants to implement toxics use reduction projects; convenes business working groups to address specific environmental challenges; conducts policy research and analysis; and provides laboratory and library services.

TURI's services include:

- Grants. TURI provides financial assistance for companies interested in converting to safer technologies. You may be eligible for a grant to help you purchase equipment, adopt a safer process, or showcase work that you've already done to reduce toxic chemical use.
