Subject: Training for TAA Program Changes Resulting From the Reversion 2014

**Purpose:** To notify Local Workforce Investment Boards, One-Stop Career Center Operator

To notify Local Workforce Investment Boards, One-Stop Career Center Operators and local workforce investment partners of changes to the Trade Programs resulting from the implementation of sunset provisions set by the Trade

Adjustment Assistance Extension Act of 2011 (TAAEA).

**Background:** The Trade Adjustment Assistance Extension Act of 2011 implemented sunset

provisions which changed benefit levels and certification criteria for workers covered by TAA petitions filed on or after January 1, 2014. The new petition series that will be utilized will start with petition 85,000 and above. The

provisions will be referred to as *Reversion 2014 (2014-R)*. Some changes revert back to the Trade Reform Act of 2002 while some rules from the TAAEA remain

the same.
