Training Highlight: Tax Rate Setting Resources

Tax rate setting requires teamwork and the cooperation of multiple local officials. A municipality's tax rate is the amount of its annual property tax levy stated in terms of a unit of its tax base. To set a tax rate, a municipality must submit a "Tax Rate Recapitulation Sheet", also called "the recap", to DLS' Bureau of Accounts. The recap displays a municipality's entire budget plan for the fiscal year. It summarizes all anticipated expenditures.

Annual Fiscal Year Waivers to Education Reform Spending Requirements and Minimum Local Contributions

The Division of Local Services has posted the Annual Fiscal Year Waivers to Education Reform Spending Requirements and Minimum Required Local Contribution Bulletin 2024-04 click here for the bulletin.

Cities, towns and regional school districts may apply for various adjustments in their FY25 minimum required contributions to schools under the Education Reform Act. Municipalities may seek adjustments if (1) non-recurring revenues were used to support FY24 operating budgets and those revenues are not available in FY25, (2) they have extraordinary non-school related expenses in FY25, or (3) their FY25 municipal revenue growth factor is at least 1.5 times the statewide average and is deemed to be excessive. See Section A-3 of IGR <u>16-301</u>.

Regional school districts that used non-recurring revenues in FY24 that are unavailable for FY25 must seek waivers if a majority of the selectmen in a town, the city council in a Plan E city or the mayor in all other cities in a majority of the member municipalities requests them. If a regional school budget has already been approved by the members and a waiver is granted of any member's minimum required local contribution to the district, the use of that waiver must be approved by the selectmen. the city council in a Plan E city or the mayor in all other cities of a majority of the member municipalities.

Cyber Resilient Massachusetts Grant Program

Cities and towns often face the challenge of planning for the future amid financial uncertainties. To effectively prepare budgets and ensure long-term financial stability, it's critical to understand how past trends have shaped the current financial landscape. The "Financial Indicators Dashboard" developed by the Financial Management Resource Bureau offers a powerful solution, providing a comprehensive business intelligence tool that allows local officials, residents and other stakeholders to visualize, track, and report on key financial and demographic trends.



This resource compiles data from various sources, including the annual Tax Recapitulation report and Schedule A submitted to the Division of Local Services, along with other state and federal databases, offering a holistic view of a community's finances and demographics. Key features include tracking property tax revenues, operating expenses, state aid, local receipts, and other critical indicators such as debt service and enterprise funds.



The MassCyberCenter at Massachusetts Technology Collaborative (MassTech) is currently accepting applications to the Cyber Resilient Massachusetts Grant Program from municipalities across the state to boost their cybersecurity infrastructure. Cities and towns that apply to the program are eligible for up to \$25,000 to fund narrowly focused cybersecurity technology upgrades, which will be identified through a cybersecurity vulnerability assessment.

The grants may fund capital equipment, technology and infrastructure for cybersecurity improvement projects including vendors/contractors or IT related staff costs of the municipality performing the upgrades. Applications are open and reviewed quarterly. The next review deadline is September 30th.

Grants will build up municipalities' defenses against cybersecurity threats. A total of \$1.4 million in funding is available.
