RULES GOVERNING TARIFF

ITEM NO. 100

GOVERNING PUBLICATIONS

This tariff is governed by the Milo Mileage Guide issued by The New England Motor Rate Bureau, Inc. and by Code 2 Freight Classification, Northeast Tariff Corp., Agent and by supplements thereto or reissues thereof.

ITEM NO. 110

DEFINITION OF "SHIPMENT"

A shipment is a lot of freight received from one shipper at one point at one time for one consignee at one destination and covered by one Bill of Lading.

ITEM NO. 112

HOLIDAYS DEFINED

Except as otherwise specifically provided, whenever in this tariff or tariffs making reference hereto, the word holiday or holidays is used, the following days shall be considered holidays:

New Years Day	Columbus Day
Martin Luther King Day	Veterans Day
Washington's Birthday	Thanksgiving Day
Memorial Day	The Day After Thanksgiving
Independence Day	Christmas Day
Labor Day	

or any other day generally observed as a holiday by the carrier at the point where the service is performed.

ITEM NO. 160

STRAIGHT OR MIXED SHIPMENTS

Unless otherwise provided, rates in this tariff or in tariffs governed by this tariff, shall apply on straight or mixed shipments of the commodities shown.

ITEM NO. 165

RATES TO BARNSTABLE COUNTY, MASSACHUSETTS

When the origin or the destination of a shipment is a point in Barnstable County, Massachusetts, apply one hundred and ten percent (110%) of the otherwise applicable rate listed herein in Item No. 3000.

ITEM NO. 170

MULTIPLES OF CLASS 1 RATES

When the rating of the commodity transported is higher than Class 1, use the following procedures:

ITEM NO. 175

EXPLANATION OF RATE SCALES 1 TO 40

As used herein, Rate Scales 1 to 40 shall apply on all movements authorized by the Operating Rights listed in Item No. 650 herein, as follows:

ITEM NO. 360

BILLS OF LADING

The Uniform Straight Bill of Lading or the Straight Bill of Lading - Short Form must be used for all shipments moving under rates herein. The name and address of only one consignor and one consignee and only one destination shall appear on the Bill of Lading.

ITEM NO. 595

MAXIMUM CHARGES

In no case shall the charge for any shipment from and to the same points via the same route of movement be greater than the charge for a greater quantity of the same commodity in the same shipping form and subject to the same packing provisions, at the rate and weight applicable to such greater quantity of freight.

ITEM NO. 750

PICK-UP AND DELIVERY SERVICE

Rates herein include pick-up and delivery of freight. "Pick-up" refers to the service of the carrier in calling for and receiving freight and issuing receipts therefor at shipper's platform or any other place directly accessible to trucks. "Delivery" refers to the service of the carrier in delivering freight at any platform, doorway or any other place designated by consignee, when directly accessible to trucks and taking receipt therefor.

Nothing in this tariff shall require the carrier to collect and/or deliver freight where it is impracticable or unsafe to operate vehicles.

Pick-up and Delivery Service will be performed at all points within the limits of all cities, towns or villages from, to or between which rates apply.
