



Natick – Route 27 over Route 9 Interchange Project

Tree Clearing Advisory

What is Happening?

Crews are scheduled to continue tree and vegetation clearing within the project limits and on impacted properties that directly abut the project.

The work on North Main Street, between Bacon Street and Route 9, is expected to start on the night of Sunday, October 19, 2025. Tree and vegetation clearing will occur on both sides of North Main Street, and along the Route 9 ramps at the interchange.

Why is this Work Happening?

Tree and vegetation removal, and clearing of properties, is a critical step to prepare the project limits for construction of the new Route 27 bridges, roadway reconstruction on Route 27 and Route 9, and construction of the pedestrian and cyclist shared-use path network. Along with these improvements, 226 new trees will be planted within the project limits.

When?

- Tree and vegetation clearings are scheduled to take place over two nights: Sunday night, October 19, and Monday night, October 20.
- Night shift work hours are 10:00 p.m. to 5:00 a.m.
- This schedule is subject to change in the event of inclement weather.

How Will this Affect You?

- Work is expected to occur in the shoulders, along walkways, on property easements, and off the roadway within the existing interchange.
- On Route 27, intermittent lane shifts are expected between Bacon Street and Route 9.
- Intermittent night time ramp closures at the interchange are required to safely perform the tree and vegetation removal. Signed detours will be installed and access for emergency services will be maintained.
- Pedestrian access, property access, and access to driveways will be maintained.
