Carpet Inspections for Water Damage

EH&S Managers Mr. Michael Lane and Mr. Michael McCarter conducted inspections of carpets identified as having potential water damage or that may be harboring mold in the Roderick L. Ireland Courthouse located at 50 State Street in Springfield, MA. The inspections were started on June 2, 2022 and completed on June 10, 2022.

The inspections consisted of visual observations, testing with a moisture meter, and by lifting up representative sections of affected carpets for visual inspection. The table below lists the locations, conditions observed, moisture meter results, and comments.
